The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. Anyone who refuses to follow Arbor Day Farm's Lied Lodge protocols and requirements will be required to leave the facility immediately and will not receive a refund for any expenses incurred by attending NAWM's Annual Meeting. This cutting-edge system safely cleans the air inside the lodge killing molds, bacteria, and viruses. They have also installed AOP filtration in their swimming pool to deliver the freshest and healthiest water quality possible and are using electrostatic sprayers to sanitize surfaces throughout the hotel.

## **Guest Rooms**

Their entire cleaning staff has been trained by Ecolab, a global leader in the manufacture and use of disinfectant products. In addition, their 10-step cleaning process helps ensure every room has been cleaned and sanitized properly.
